Spaces are 10' x 10'.**

Only exhibitors who are selling their own hand-made art or crafts will be accepted. No kits, imports, manufactured or retail merchandise will be accepted. If you display items not hand-made, you will be asked to leave and forfeit your table fees.

Jury Procedure: Only crafts people who design and produce their own work are eligible and must be present for the entire event.

Requirements: Please submit 5 photos (discs are acceptable) of the work, one of workshop (if applicable) and one of overall booth. Photo's should be labeled and include a description of the work and price ranges. **Photos will not be returned by mail.** Photos can be picked up at the DBCA tent the weekend of the show. Items offered the days of show must be consistent with items juried; booth must look neat and professional. All applicants must send in photos, participation in past shows does not guarantee acceptance/placement in show. Jury decisions are based on creativity, marketability, quality of workmanship, and balance of craft media for a broad public appeal. **Be sure to include your e-mail address for confirmation of your acceptance to the show.**

Applications cannot be processed without complete payment (2 separate checks), photos and 3 copies of your application.

Booth locations: Location requests will be considered but are not guaranteed. The final booth space assignment list will be available online, with the map, one week prior to the show date with specific information for setup and parking. Displays must not block sidewalks and all tables must be covered to the ground with packing materials neatly out of sight. No electric is available and displays must be broken down Saturday night, and reset on Sunday. No displays should be dismantled before closing time and street closures must be observed. Saturday and Sunday 7am-6pm. unload promptly and move vehicles before setting up display.

Application Deadline date: for early registration only: April 30, 2012 (applications still accepted after April 30)

Refunds: No refunds

Weather cancellation: Fees are non-refundable.
